



Impact By the Numbers

Networking for Impact

1,842 individual members <u>engaged with one another</u> in online and in person experiences. TAG's generous and welcoming community is a valuable and supportive network that helps individual members do more good.



Learning to Transform Organization Practice

275 members attend 4 <u>TAGlocal events</u> held in Chicago, New York, Washington DC, and San Francisco, where they worked collaboratively to develop strategies to manage change in the era of Al.

TAG launched its first-ever learning exchange cohort to advance innovative AI practices in philanthropy.




Sharing to Inform the Field of Philanthropy
